I. Safe2Say Something Overview

In 2018, the General Assembly passed Act 44, which mandated the Office of Attorney General to establish the “Safe2Say Something” (S2SS) anonymous reporting system and required every Pennsylvania school entity to participate in the program by January 14, 2019.

S2SS is a life-saving and life-changing school safety program that teaches students, educators, and administrators how: (1) to recognize the signs and signals of individuals who may be at risk of hurting themselves or others, and (2) to anonymously report this information through the S2SS app, website, or 24/7 Crisis Center Hotline.

The OAG, in partnership with Sandy Hook Promise (SHP), a leader in anonymous reporting systems, has built out the app, website, and PA-based 24/7 Crisis Center. SHP is a national non-profit committed to creating safe schools and communities through their four evidenced-based Know the Signs intervention programs.

Students, educators and administrators have the opportunity to be trained to recognize the signs and signals of individuals who may be at risk of hurting themselves or others along with how to use the S2SS anonymous reporting system to submit tips of the signs and signals they observe.

OAG Crisis Center analysts are trained to vet and triage tips by: (1) conducting 2-way anonymous dialog with tipsters to gather missing information and ensure enough information is provided for schools and local law enforcement to act upon, (2) categorizing each tip as either “Life Safety” or “Non-Life Safety,” for ease of prioritization by tip recipients, and (3) delivering the tip to the impacted school and, when needed, its local law enforcement via 911 county dispatch.



II. Reporting Requirements

In accordance with Act 44 of 2018, Section 1307-D (a), the Safe2Say Something Program Annual Report is respectfully submitted to the chairperson and minority chairperson of the House and Senate Appropriations Committees, and the chairperson and the minority chairperson of the House and Senate Education Committees.

As required by law, the data included covers the previous school year, starting July 1, 2022 through June 30, 2023, related to the following:

- The number of reports received for the previous school year.
- The total number of reports received since the program began.
- A breakdown of reports by type.
- A breakdown of the method by which the report was received.
- A breakdown of the reports by Intermediate Unit, utilizing only aggregate data.
- The total cost to operate the program, including staffing costs, administrative costs, and support costs.
- The total number of false reports received.
- Any other information the Attorney General deems appropriate.

III. Findings for the 2023-2024 School Year, July 1, 2023 –June 30, 2024

1. Number of reports received, and total number of report received since the launch of the program (January 14, 2019).

Since the launch of the program, the tip line has received **146,513 tips**. This number excludes any false reports received, as well as any test tips to the system.

For the 2023-2024 school year, the Safe2Say Something program received **32,873 tips**. This number also excludes false report received, and any test tips.



2. Breakdown of reports by type.

The chart below represents a breakdown of reports by type and includes the top 10 categories of tips received by the Safe2Say Program in the 2023-2024 school year. The Safe2Say Something Program has 34 different event types to choose from on the mobile application as well as additional event types that only the Safe2Say Something Investigative Analysts can designate during triage.

It is important to note that during the 2023-2024 school year, the Safe2Say Program has removed Smoking (Tobacco, E-Cig, Vape) in School as an event type, however, this did not prevent students from submitting tips on smoking or vaping utilizing another event type. The Safe2Say Program will still categorize these tips appropriately and send them to the school team. Investigative Analysts send responses to tipsters and provide available resources for students who are having issues with smoking or vaping. We will continue to educate students to directly reach out to a trusted adult for and concerns related to smoking or vaping use in schools.

3. Breakdown of the method by which the report was received.

Reports can be received by the Safe2Say Something Program in 4 ways. A report can be submitted via the Safe2Say Something mobile application, which is available for download. Reports can also be submitted through the Safe2Say Something website, as well as calling the hotline and speaking to an investigative analyst directly. This year, a new method has been added, allowing reports to be submitted via text message.

The chart below represents the breakdown of the method by which tips were submitted. The website submissions are further broken down between tips that are submitted via a PC and tips submitted using a mobile browser (i.e., cell phone or tablet).

5. The total cost to operate the program, including staffing costs, administrative costs and support cost.

The following figure represents the **fiscal year** cost for operation of the crisis center, continuing education, and outreach for the program: **\$2.0 Million.**

6. The total number of false reports received

The Office of Attorney General classifies false reports into 2 categories: tips immediately identified as being false, and those determined to be false based off an investigation conducted by the school team or police. The number of false reports made to the system this year is at 4%.

During the 2023 – 2024 school year, the Safe2Say Something Program has received a total of 1,361 tips that were designated as false reports or prank tips.

There was a total of 747 tips that were immediately identified as prank tips by the crisis center analysts. These tips were delivered to the school account without sending a notification to the school team.

There was a total of 614 tips containing the disposition of "Deliberate Abuse of System" which are tips that contain seemingly credible information yet proven untrue upon investigation; or the information was provided with the intention to harm or disrupt.

False tips submitted to Safe2Say present safety risks to students and drain program and law enforcement resources. While false tips are rare, it is critical to the success of the program to keep false tips rare. The Office of Attorney General (OAG) encourages District Attorneys to investigate and file charges in the event of a false tip as a deterrent, and the OAG is prepared to assist local District Attorneys in these investigations.



7. Total number of schools and students trained

Student training was offered this year through either self-led trainings, an in person trainer, or using an interactive video. The number of students that received Safe2Say Something training during the 2023– 2024 school year totaled 564,392.

IV. Comparison from Previous Reports

In the previous school year (July 1, 2022 – June 30, 2023), the Safe2Say Something Program received **31,027** tips. During the 2023-2024 school year, (July 1, 2023 – June 30, 2024), the Safe2Say Something Program received 32,873 tips, which was a 6% increase. The Safe2Say Something Program has received more tips this school year than any year prior. This year, Life Safety Tips accounted for 12% of all tips received, marking a slight decline from the previous school year.

V. Conclusion and Recommendation

The Safe2Say Something Program tip line has again seen an increase in tips received to the program during the 2023-2024 school year. This data shows that students continue to face significant mental health concerns as well as issues with substance abuse.

The data reveals several significant increases in Safe2Say Something reports. Reports of “Threat Against Person” saw the highest increase, rising by 64%, indicating a concerning escalation in personal safety threats. This school year, 35 weapons were recovered as a result of tips received to the Safe2Say Something Program, bringing the total number of weapons recovered to 123 since the program’s launch.

Incidents of Inappropriate Language, Behavior, or Gestures increased by 49%, suggesting either a shift in social behavior or increased vigilance and reporting. Additionally, reports of Bullying and Cyber Bullying increased by 25%, likely influenced by the widespread use of social media, which has amplified opportunities for cyberbullying and made it more challenging to control. The significant impact of this behavior on students, extending well beyond the school day, emphasizes the need for measures to reduce students' ability to use and sometimes abuse social media. We encourage the General Assembly to continue examining the impact of social media on the Commonwealth’s children and exploring possible solutions. Creating a safe space for children, both in and out of the classroom, remains a critical priority.

In the 2024-25 Budget, the General Assembly took the necessary step to appropriate funds for increased mental health services in schools. As in previous years, we encourage the General Assembly to analyze the data and take steps to ensure the safety and wellbeing of our children. We also encourage to increase education on substance abuse and provide students and their families any available resources for assistance. The Safe2Say Something Program will continue to partner with our school districts to ensure additional student trainings are taking place.
